Field # 1 -- Business Name

Field #'s 2 – Identification Number

Field # 3 -- Date Of Original Certificate

List the date that the original certificate of the foreign Limited Partnership was filed in the State Treasurer's Office.

Field # 4 -- Amendment

List the article from the original registration certificate that is being amended along with the text of the amendment, including a name change if applicable. If you are changing the name, the name availability provisions apply:
