**To file electronically:**

1. Enter the information requested below and sign by typing your name in the signature field. The form can only be filled in using the free Adobe Acrobat Reader 9.1 or greater. *(See the pages following this form for field by field instructions, and notes on delivery and processing of work requests.)*  
2. Click the "Add Attachments" button to add attachments if required *(Check the field by field instructions to see if you must include an attachment(s)).*  
3. After the form has been filled in properly, please save a copy to your computer so that you can upload the form to the State of New Jersey Division of Revenue & Enterprise Services Central Forms Repository Web application by following the instructions in the next step.  
4. Click the "Open the Central Forms Repository Home Page to start the Form Submission Process" button at the bottom of the form.  
*(This action will launch the State of New Jersey Division of Revenue & Enterprise Services Central Forms Repository Web application. If you have not created an account in the application, you will need to do so before using the online Web application. Once your account is created, please login to the application and follow the instructions for submitting your form and payment online.)*

Instructions for Form UNRR-4

**APPLICATION FOR REGISTRATION OF A FOREIGN BUSINESS NAME**

This document registers the use of a business name in New Jersey. Since there are no provisions for a foreign LLC to register a business name, a LLC may opt to reserve a business name either online or by using [Form UNRR-1](#) . If you wish to obtain authority to do business in this State, you must also file form [“Public Records Filing for New Business Entity”](#) . This document is in addition to [tax and employer registration](#) .

STATUTORY FEE: **See Below**

The MANDATORY fields are:

***Field # 1 -- Business Type***

Choose the business type/statutory authority under which you are filing:

\$50 For-Profit Corporation (Title 14A)

\$50 Non-Profit Corporation (Title 15A)

\$50 Limited Partnership (Title 42:2A)

***Field #2 -- Business Name***

List the business name to registered.

**\*\***The name must be distinguishable from other names on the State's database. The Division of Revenue will check the proposed name for availability as part of the filing review process.

***Field #3 -- State of Incorporation/Formation***

List the state or jurisdiction in which the business incorporated, formed, etc.

***Field #4 -- Main Business Address of Applicant***

List the main business address.

***ATTESTATIONS***

Provide statements that indicate: 1) the business is currently engaged in and conducting business; 2) the business is in good standing; and 3) the signers are authorized to sign on behalf of the business. Form UNRR-4 provides these statements.

***ATTACHMENTS***

Corporations must attach a certificate of good standing dated not more than 30 days prior to filing with the State of New Jersey.

***EXECUTION (Signature/Date)***

Have the appropriate party sign and date the application:

Corporations -- chairman, president or vice-president

Limited Partnerships -- a general partner
